THE EMPLOYMENT SECURITY CONCIL (ESC)**

This meeting, conducted by the Administrator of the Employment Security Division (ESD) and the Employment Security Council (ESC), is a workshop to review, discuss and solicit comment on a proposed amendment of a regulation pertaining to Chapter 612 of the Nevada Administrative Code pursuant to Nevada Revised Statute (NRS) 233B.061. The proposed amendment will establish the Unemployment Insurance Tax Rate Schedule for Nevada employers for calendar year 2024. During this meeting there will also be a review of amendment/clarification to NAC 612.120, 612.290, 612.470, and 612.660 to add “electronically transmitted” to the stated regulations, review for possible removal of NAC 612.665 through NAC.685 (related to the defunct business startup program for Seniors and Veterans), review for possible removal of NAC 612.590 through 612.625 related to an unnecessary unemployment compensation bond fund, removal or cleanup of NAC 612.056 due to conflicts with NRS 612.265, review for possible removal of NAC 394.700 through NAC 394.730 related to the Alcoholic Beverage Awareness program, and review for possible removal of NAC 394.600 due to a burden on licensed institutions.

**I. CALL TO ORDER AND WELCOME**

Chairman Jeffrey Frischmann identified himself as the chairman for Nevada Employment Security Council, thanked the members of the Council, the public and staff for their participation in today's Employment Security Council Meeting and called the meeting to order.

## **VIII. EMPLOYMENT SECURITY COUNCIL APPROVAL OR RECOMMENDED UI TAX RATE FOR YEAR 2024**

Chairman Frischmann began by opening the floor from any comments from the Council member on their thoughts on a motion. Mr. Costa gave his opinions along with Mr. Guzman who both agreed that the UI tax rate should remain the same for FY24 as it was for FY23. Mr. Susich motioned and 2<sup>nd</sup> by Mr. Billings. Mr. Guzman then asked that the motion reads as follows, “to recommend the UI tax rate of 1.70% will remain the same as 2023”.

The call to vote resulted in 6 ayes, 0 nays, and 0 abstentions, and the motion passed unanimously.

## **IX. REVIEW & CONSIDERATION OF NEVADA ADMINISTRATIVE CODE**

Employment Security Division Administrator, Kristine Nelson, presented the following items as merely a presentation, an introduction in the regulatory rulemaking process at this public hearing.

- d. Item 9D - Proposes the removal of Nevada Administrative Code regulation 612.056.
- e. Item 9E - Proposes the removal of Nevada Administrative Code regulations 394.700 – 394.730.
- f. Item 9F - proposes the removal of Nevada Administrative Code regulation 394.600.

The chairman then opened the vote, and as all members of the ESD Council unanimously voted AYE to adjourn, Mr. Frischmann thanked everyone and adjourned the meeting.
