SUBJECT: Next Interim Finance Committee Meeting

Please place the following items on the agenda of the October 16, 2025 Interim Finance Committee meeting:

**I. WORK PROGRAMS**

1. **DEPARTMENT OF HUMAN SERVICES - AGING AND DISABILITY SERVICES - FY 26**  
Addition of \$3,035,448 in federal Older Americans Act (OAA) Title III-B Supportive Services formula grant funds to continue to provide subawards for community-based services for older adults, their caregivers, and other individuals eligible under the OAA. Requires Interim Finance Committee approval since the amount added to the Title III-B Social Services category exceeds \$350,000. **Work Program #C77147**
2. **STATE DEPARTMENT OF CONSERVATION AND NATURAL RESOURCES - FORESTRY - ADMINISTRATION - FY 26**  
Addition of \$145,999 in federal USDA Forest Service funds to supports the Nevada Division of Forestry in safeguarding forest lands that are environmentally and socially significant and threatened by development and other non-forest uses. Requires Interim Finance Committee approval since the amount added to the USFS Legacy category exceeds 20% of the legislatively approved amount for that category. **Work Program #C77468**
3. **STATE DEPARTMENT OF CONSERVATION AND NATURAL RESOURCES - FORESTRY - ADMINISTRATION - FY 26**

Addition of \$1,552,494 federal USDA Forest Service funds, Good Neighbor Agreement funds to true up authority for the Humbolt Toiyabe National forest Agreements which provide a cooperative framework between parties for reducing hazardous fuels and enhancing forest, rangeland, and watershed health within the Sierra and Elko Front Wildfire Crisis Strategy Landscape. Requires Interim Finance Committee approval since the amount added to the Humbolt Toiyabe National Forest-Sierra/Elko Fronts Good Neighbor category exceeds the \$350,000. **Work Program #C77492**

**4. STATE PUBLIC CHARTER SCHOOL AUTHORITY - FY 26**

Addition of \$270,830 in federal Title III English Language Learners and \$24,268 in the federal Title III Immigrant grant funds transferred from the Nevada Department of Education to continue improving the education of immigrant and limited English proficient children and youths. Requires Interim Finance Committee approval since the amount added to the federal Title III English Language Learner category exceeds 20% of the legislatively approved amount for that category. **Work Program #C77821**

**5. DEPARTMENT OF HUMAN SERVICES - AGING AND DISABILITY SERVICES - FY 26**

Addition of \$206,707 in federal Older Americans Act (OAA) Title III-D Preventative Health formula grant funds to continue to provide subawards for evidence-based programs that promote health and prevent disease among older adults. Requires Interim Finance Committee approval since the amount added to the Title III-D Preventative Health category exceeds 20% of the legislatively approved amount for that category. **Work Program #C77832**

**6. GOVERNOR'S OFFICE OF ECONOMIC DEVELOPMENT - FY 26**

Addition of \$497,420 in federal Economic Development Administration funds transferred from the University of Nevada, Reno, to provide specialized career and skill development. Requires Interim Finance Committee approval since the amount added to the UNR Tech Hubs Grant category exceeds \$350,000. **Work Program #C77840**
