SUBJECT: Next Interim Finance Committee Meeting

Please place the following items on the agenda of the October 16, 2025 Interim Finance Committee meeting:

I. WORK PROGRAMS

21. STATE DEPARTMENT OF CONSERVATION AND NATURAL RESOURCES - FORESTRY - ADMINISTRATION - FY 26

Addition of \$529,617 in federal funding to true up grant authority provided by the Infrastructure Investment and Jobs Act(IIJA), otherwise known as the Bipartisan Infrastructure Law (BIL) - Community Wildfire Defense Grant (CWDG) to support various activities that help communities participate in the program. Requires Interim Finance Committee approval since the amount added to the IIJA/BIL - CWDG Grant category exceeds \$350,000. **Work Program #C77416**

22. DEPARTMENT OF BUSINESS AND INDUSTRY - LABOR COMMISSION - FY 26

Addition of \$695,737 in federal United States Department of Labor - Apprenticeship USA Grant funds to expand and develop state apprenticeship opportunities. Requires Interim Finance approval since the amount added to the State Apprenticeship Program category exceeds \$350,000. **Work Program** #C77669

23. DEPARTMENT OF BUSINESS AND INDUSTRY - DIVISION OF INDUSTRIAL RELATIONS - FY 26

Addition of \$215,000 in Workers' Compensation and Safety Fund funds to carry out the provisions of

Senate Bill 317 (SB 317) from the 83rd (2025) Legislative Session. Requires Interim Finance Committee approval since the amount added to the Card Claim Management System category exceeds 20% of the legislatively approved amount for that category. **Work Program #C77813**

24. NEVADA HEALTH AUTHORITY - NEVADA MEDICAID - IMPROVE EMT QUALITY AND ACCESS - FY 26

Addition of \$7,652,386 in Assessment revenue and \$21,440 in Treasurer's Interest Distribution revenue to establish emergency medical transportation services. Requires Interim Finance Committee approval since the amount added to the Transfer to Medicaid BA 3243 category exceeds \$350,000. This is a companion to work program C78577. **Work Program #C78587**

25. NEVADA HEALTH AUTHORITY - NEVADA MEDICAID - MEDICAID - FY 26

Addition of \$10,292,068 in federal Title XIX Receipts and \$6,887,147 in Transfer for Planning from the Nevada Health Authority, Improve EMT Quality and Access account to provide enhanced rates of reimbursement to private EMT providers. Requires Interim Finance Committee approval since the amount added to the Offline category exceeds \$350,000. This is a companion to work program C78587. Work Program #C78577

26. NEVADA HEALTH AUTHORITY - DIRECTOR'S OFFICE - ADMINISTRATION - FY 26

Addition of \$518,400 in Katie Becket Premium revenue to offset costs associated with the program. Requires Interim Finance Committee approval since the amount added to the Operating category exceeds \$350,000. **Work Program #C78628**

27. NEVADA HEALTH AUTHORITY - DIRECTOR'S OFFICE - ADMINISTRATION - FY 26

Addition of \$2,367,954 in federal Title XIX Receipts and \$263,106 in Transfer from Budget Account 3177 funds to cover costs associated with improved reporting. Requires Interim Finance Committee approval since the amount added to the Fiscal Agent category exceeds \$350,000. **Work Program** #C78722
