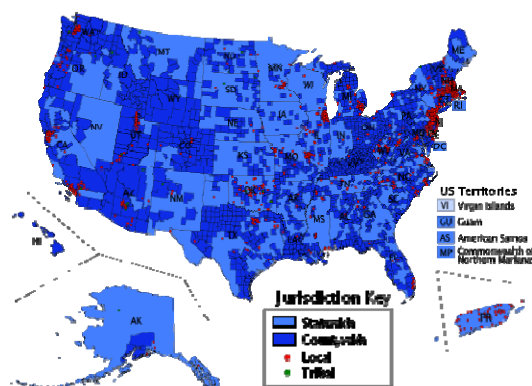

ABOUT CITIZEN CORPS

Citizen Corps was initiated by a Presidential Executive Order to capture the national spirit of compassion and service in the immediate aftermath of September 11, 2001 and was launched during the State of the Union Address on January 29, 2002. Today, over 2,300 State, tribal, and local Citizen Corps Councils nationwide bring together community and government leaders to involve citizens and organizations in emergency preparedness, planning, mitigation, response and recovery. These Councils enable collaborative planning between government and civic leaders and provide localized support for outreach and educational efforts to the public. Citizen Corps Councils also support training and exercises that effectively integrate emergency responders, volunteers with a response role, and the general public, and promote volunteer programs that augment the full range of emergency response services.



The Citizen Corps grassroots strategy is based on the following tenets:

- Government must collaborate with civic leaders
- Local implementation is essential and builds on successful efforts already in place
- National support must include consistent policy and guidance, tools and resources adaptable for local use, and building awareness through a national voice

Citizen Corps is administered nationally by FEMA's Community Preparedness Division with support from throughout the Agency. The responsibilities of the Division are to:

- Serve as the integrating organizational entity for FEMA tools and resources to support community preparedness
- Work with current national partners and expand our partnerships to enhance the tools and resources available to local communities
- Expand education, training, and exercises for the public and make it more accessible to all, including preparedness education and CERT
- Promote volunteer service opportunities to support community safety and resilience
- Conduct research on individual, business, and community preparedness and analyze/synthesize the research of others

Distinguished Keynote Speakers:



William Craig Fugate

Administrator, Federal Emergency Management Agency

W. Craig Fugate began serving in the position of Administrator of the Federal Emergency Management Agency (FEMA) in May 2009. Prior to coming to FEMA, Mr. Fugate served as Director of the Florida Division of Emergency Management (FDEM). In that role since 2001, he managed 138 full-time staff and a budget of \$745 million. His agency coordinated disaster response, recovery, preparedness and mitigation efforts with each of the state's 67 counties and local governments.

Mr. Fugate began his emergency management career as a volunteer firefighter, Emergency Paramedic, and finally as a Lieutenant with the Alachua County Fire Rescue. Eventually, he moved from exclusive fire rescue operations to serving as the Emergency Manager for Alachua County in Gainesville, Florida. He spent a

decade in that role until May 1997 when he was appointed Bureau Chief for Preparedness and Response for the Florida Division of Emergency Management (FDEM). Within FDEM, Mr. Fugate's role as Chief of the State Emergency Response Team (SERT) kept him busy during 1998. That year, the SERT team was active for more than 200 days as a result of numerous floods, tornadoes, wildfires, and Hurricane Georges.

In September 2003, again under Mr. Fugate's stewardship, the Florida Emergency Management Program became the first statewide emergency management program in the nation to receive full accreditation from the Emergency Management Accreditation Program (EMAP). During his years at FDEM, Mr. Fugate served as the State Coordinating Officer in Florida for 11 Presidentially-declared disasters and the management of \$4.5 billion in federal disaster assistance.

In 2004, Mr. Fugate managed the largest federal disaster response in Florida history as four major hurricanes impacted the state in quick succession (Charlie, Frances, Ivan and Jean). In 2005, Florida was again impacted by major disasters when three more hurricanes made landfall in the state (Dennis, Katrina and Wilma). The impact from Hurricane Katrina was felt more strongly in the Gulf Coast states to the west but under the Emergency Management Assistance Compact or EMAC, Florida launched the largest mutual aid response in its history in support of those states.

In recent years, Florida avoided major hurricane impact although Tropical Storm Fay in 2008 historically made landfall to the state four different times. Mr. Fugate has spent this time focusing FDEM on preparedness and planning for the future.



David Maxwell

Incoming President, National Emergency Management Association

Mr. David Maxwell was appointed on June 30, 2006 as Director of the Arkansas Department of Emergency Management (ADEM) and State Homeland Security Adviser. He served as ADEM's Deputy Director from March 2002 until this appointment. He has 30 years of service with the agency.

As Director, Maxwell chairs the Arkansas Homeland Security Executive Committee and serves on the Arkansas Terrorism Task Force, Arkansas Governor's Earthquake Advisory Council, Arkansas Fire Protection Board, State Emergency Response Commission, Arkansas Wireless Information Network Steering Committee, Arkansas Tech Emergency Administration and Management Citizens Advisory Council, and Pine Bluff Arsenal Citizen Advisory Commission. In September 2008, David was

elected as 2009 Vice President of the National Emergency Managers Association (NEMA) and will go on to serve as President in 2010. After his term as president he will serve as an advisor to the next president. David also serves as Vice Chair on the Board of Directors of the Central United States Earthquake Consortium (CUSEC).

In 1978, he began his career in emergency management working in temporary housing for the State after major



flooding in Little Rock, Arkansas, and was promoted to Planning Specialist in 1980. Later he advanced to ADEM's Plans and Operations Division Manager. In that capacity, he ensured the State Emergency Operations Plan and local jurisdictional plans were maintained and in compliance with state and federal guidelines. Mr. Maxwell led the division in its mission of coordinating state response and recovery operations, collaborating with federal and local governments, and volunteer agencies with disaster response or recovery responsibilities. David Maxwell served as the designated State Coordinating Officer for seven federally declared disasters and one federally declared emergency.

David Maxwell has a Master's Degree in Sociology from Henderson State University in Arkadelphia, Arkansas with a Bachelor's Degree from Arkansas Tech University.



Russ Decker, MS, CEM

IAEM-USA President, International Association of Emergency Managers

Russ Decker is Director of the Allen County Office of Homeland Security & Emergency Management. He began as a volunteer with the agency in 1990, and has served as Director since 1998. As Director he oversees the agency's \$4.1M budget, including a regional HAZMAT Team and Bomb Squad. Mr. Decker currently serves as National President for the International Association of Emergency Managers (IAEM), the nation's largest emergency management professional association.

In June of 2007, Mr. Decker was appointed to the 35-member National Advisory Council for FEMA, where he now Chairs the Standing Committee on the National Incident Management System (NIMS). He also was a senior Steering Committee

member responsible for the creation of the new National Response Framework that was released in Jan. of 2008.

Mr. Decker has testified before the U. S. Senate and House of Representatives on the topic of community preparedness. He is the co-author of *Homeland Security: Handbook for Citizens and Public Officials* and will have his first full book published later this year, *Breaking News: An Emergency Responder's Guide to the Media*.

Mr. Decker received the prestigious Clayton R. Christopher Award in 2006, recognizing him as the nation's leading local emergency manager. He received the Excellence in Public Service Award from the Ohio Chemistry Technology Council in 2005. He served as President of the Emergency Management Association of Ohio (2002-2003). He is an adjunct professor of criminal justice at Tiffin University and a part-time faculty member at Ohio Northern University where he teaches Environmental Law. Mr. Decker holds a Master of Science degree from Tiffin University, with undergraduate studies from The Ohio State University and the University of Northwestern Ohio. He completed FEMA's Professional Development Series in 2001.

Keynote Speakers:



Amanda Ripley

Author, *The Unthinkable: Who Survives When Disaster Strikes - and Why*

Amanda Ripley is the author of *The Unthinkable*, the first mass-market book to explain how the brain works in disasters. Ms. Ripley's work is unusual and compelling. She doesn't just explain what happens in disasters; she extensively investigates why people do what they do, and how we can do better, combining science with storytelling.

As a longtime contributor at TIME Magazine, Ms. Ripley has traveled the world studying disasters, natural and man made. She chronicled Hurricanes Katrina and Rita from New Orleans, helping TIME win two National Magazine Awards. She covered 9/11 from Manhattan, the sniper attacks in and around Washington, DC, and from Paris, the catastrophic 2003 European heat wave which killed an estimated 50,000 people. Ms. Ripley has received awards from the Society of Professional

Journalists, the Newswomen's Club of New York and the Washington Monthly, among others, and she is a two-time Livingston Award finalist.



Richard J. Hatchett, M.D.

Director, Medical Preparedness Policy, White House National Security Staff

Dr. Hatchett is the Director for Medical Preparedness Policy on the White House National Security Staff where he is working on a wide array of issues relating to the 2009-H1N1 response. In 2005-6, he served as Director for Biodefense Policy on the White House Homeland Security Council and was a principal author of the National Strategy for Pandemic Influenza Implementation Plan. In this capacity, he helped set policy and devise strategies to mitigate the consequences of a pandemic and promote pandemic preparedness.

Dr. Hatchett is also Associate Director for Radiation Countermeasures Research and Emergency Preparedness at the National Institute for Allergy and Infectious Disease, overseeing a program that develops drugs and devices to prevent or mitigate the effects of radiation exposure.

Dr. Hatchett previously served as Senior Medical Adviser in the U.S. Department of Health and Human Services (HHS) Office of Public Health Emergency Preparedness, where he worked on a wide range of biodefense issues, including the delivery of mass prophylaxis to urban populations, the development of disease containment strategies, and the role of modeling in the formulation of public health policy.

Dr. Hatchett completed his undergraduate and medical educations at Vanderbilt University, an internship and residency in Internal Medicine at New York Hospital – Cornell Medical Center, and a fellowship in Medical Oncology at the Duke University Medical Center.

Dr. Hatchett will provide an update on the status of the 2009-H1N1 pandemic and the U.S. government's efforts to prepare for what is likely to be a large wave of illness in the Fall that could begin as soon as late August or early September. He will review recent data from both the United States and the Southern Hemisphere, describe the challenges we are likely to face over the next several months, discuss the major pillars of the national response, and focus on ways that civic and volunteer organizations, working in concert with State and local public health and emergency response organizations, can contribute to the mitigation of illness, suffering, and death.



Bruce Lockwood, CEM

Member, National Commission on Children and Disasters

President, International Association of Emergency Managers USA Council (IAEM-USA) Region 1

Bruce Lockwood is a member of the National Commission on Children and Disasters and a Certified Emergency Manager® with 25 of years experience in emergency management, emergency medical services and public safety.

As a result of Mr. Lockwood's extensive expertise in public safety and emergency planning specific to the unique needs of children, he was nominated by Speaker of the House Nancy Pelosi to join the National Commission on Children and Disasters in 2008.

The Commission consists of ten members and is charged with conducting a comprehensive study to examine and assess the needs of children in preparation for, response to, and recovery from all hazards, including major disasters and emergencies.

Mr. Lockwood is currently the public health emergency response coordinator for the Bristol-Burlington Health District in Connecticut, the president of the International Association of Emergency Managers USA Council (IAEM-USA) Region 1, and serves on the IAEM Government Affairs Committee. He has held many key positions, such as: Canton Schools All Hazard Planning Chair (1999-2007); member of the Governor's Prevention Partnership School Safety Portal Committee; member of the Child Safety and Crisis Response, State of Connecticut, Daycare and Child Care Subcommittee; member of the State of Connecticut Public Health Emergency Preparedness Advisory Committee; and founder and president of the Connecticut Emergency Management Association.



Janet Napolitano, J.D.

Secretary, U.S. Department of Homeland Security

Janet Napolitano was sworn in on January 21, 2009 as the third Secretary of the Department of Homeland Security. Prior to joining the Obama Administration, Napolitano was mid-way through her second term as governor of the state of Arizona. While governor, Napolitano became the first woman to chair the National Governors Association, where she was instrumental in creating the Public Safety Task Force and the Homeland Security Advisors Council. She also chaired the Western Governors Association. Napolitano previously served as the Attorney General of Arizona and the U.S. Attorney for the District of Arizona.

Napolitano's homeland security background is extensive. As U.S. Attorney, she helped lead the domestic terrorism investigation into the Oklahoma City Bombing. As Arizona Attorney General, she helped write the law to break up human smuggling rings. As governor, she implemented one of the first state homeland security strategies in the nation, opened the first state counter-terrorism center and spearheaded efforts to transform immigration enforcement. She's also been a pioneer in coordinating federal, state, local and bi-national homeland security efforts, and presided over large scale disaster relief efforts and readiness exercises to ensure well-crafted and functional emergency plans.

Napolitano graduated from Santa Clara University in 1979, where she won a Truman Scholarship, and received her Juris Doctor (J.D.) in 1983 from the University of Virginia School of Law. After law school she served as a law clerk for Judge Mary M. Schroeder of the U.S. Court of Appeals for the Ninth Circuit before joining the law firm of Lewis and Roca.



Jane Holl Lute, Ph.D., J.D.

Deputy Secretary, U.S. Department of Homeland Security

Deputy Secretary Jane Holl Lute has over thirty years of military and senior executive experience in the United States government and at the heart of efforts to prevent and resolve international crises.

Ms. Lute served as Assistant Secretary-General of the United Nations, responsible for support to peacekeeping operations. In this capacity, Ms. Lute managed operational support for the second-largest deployed military presence in the world. At the United Nations, Ms. Lute led rapid-response support to a wide variety of operations and crises in some of the most remote, austere, and dangerous environments in the world. She also effectively directed the growth of United Nations Peacekeeping support from a \$1.8 billion to nearly \$8 billion operation. Most recently, Ms. Lute led the United Nations initiative designed to coordinate efforts to build sustainable peace in countries emerging from violent conflict.

Prior to joining the United Nations, Ms. Lute served on the National Security Council staff under both President George H.W. Bush and President William Jefferson Clinton.

Ms. Lute was Executive Vice-President and Chief Operating Officer of the United Nations Foundation and the Better World Fund, the entities established to administer Ted Turner's \$1 billion contribution to support the goals of the United Nations. She also headed the Carnegie Commission on Preventing Deadly Conflict and was a senior public policy fellow at the Woodrow Wilson International Center for Scholars.

Ms. Lute had a distinguished career in the United States Army, including service in the Gulf during Operation Desert Storm. Ms. Lute has a Ph.D. in political science from Stanford University, and a J.D. from Georgetown University.



Tim Manning

**Deputy Administrator, Federal Emergency Management Agency,
National Preparedness Directorate**

Tim Manning is the Deputy Administrator of the National Preparedness Directorate (NPD) at the Federal Emergency Management Agency (FEMA). The Directorate has six business units with more than 300 personnel who are charged with providing guidance, programs, activities and services to prepare the Nation to prevent, protect from, respond to and recover from all hazards.

Prior to this assignment, he served as the Secretary of the New Mexico Department of Homeland Security and Emergency Management, and Homeland Security Advisor to the Governor. He was named the Department's first Director by the Governor in April 2007, having previously been appointed to the Cabinet as Director of the Governor's Office of Homeland Security in 2005 and before that served as the State Director of Emergency Management. In addition to the State's intelligence and anti-terrorism programs, Deputy Administrator Manning also oversaw the daily administration of the State's disaster and emergency preparedness, mitigation, response, and recovery efforts.

Deputy Administrator Manning has previously served as a Deputy Cabinet Secretary of the New Mexico Department of Public Safety. He has a diverse background in emergency services, working in a number of positions in the State's emergency management agency from entering as the hazardous materials response program coordinator up through to the Chief of the Emergency Operations Bureau, and eventually the agency's Director. Prior to his service with New Mexico, Deputy Administrator Manning served as a firefighter, EMT, rescue mountaineer and hazardous materials specialist.

Deputy Administrator Manning received a Bachelors of Science in Geology from Eastern Illinois University, and is a graduate of the Executive Program at the Center for Homeland Defense and Security of the Naval Postgraduate School.

In February 2008, the Federal Emergency Management Agency announced the selection of Captain W. Russell Webster, USCG (Retired) as FEMA Region I's first Federal Preparedness Coordinator (FPC). Captain Webster is a 1977 graduate of the US Coast Guard Academy in New London, Connecticut and a 1996 graduate of the Naval War College in Newport, RI. During his 26 year military service, he served in two ships and commanded two shore stations, including US Coast Guard Group Woods Hole, Massachusetts, the largest shore rescue unit in the United States. During that tour, he was the Coast Guard's Incident Commander for the response to both the JFK Jr and Egypt Air flight 990 air crashes in 1999. In 2001, he was the director for Coast Guard operations from Maine to New Jersey and coordinated regional operations in response to the 9-11 terrorist attacks. Upon retirement from the Coast Guard in 2003, he transitioned to DHS civilian service with the Transportation Security Administration, where he occupied three positions at Logan Airport, a Category X airport that was the hub for seven other airports throughout the Commonwealth of Massachusetts. During his four and a half years with TSA Boston, he co-lead a planning effort with 30 regional local, state and federal stakeholders with a vested interest in preventing and responding to terrorist attacks in the transportation systems. That effort produced groundbreaking memorandums of understanding and a shared strategic plan developed by and for the partners.

During 2002, Freddy was hired as Disaster Coordinator of Training and Volunteers for the American Red Cross of Greater Miami & The Keys Chapter, where he coordinated all Human Resources during disasters from Plane Crash, to single family home fires. He also served as the Liaison between American Red Cross and all Miami-Dade, City of Miami and Hialeah Fire Departments. Freddy has responded to over 15,000 single and multi-family fires during his five years as an employee of the American Red Cross. Additionally, he has staffed over 15 shelters during hurricane season 2005 and staffed mobile units that fed over 2.5 million meals. He has dedicated over 10,000 hours to the programs and services of the American Red Cross and is the recipient of the Presidential Call to Services Award.

Employing the hallmark Socratic dialogue format of the *Fred Friendly Seminars*, this series delves into the thorny ethical and practical challenges raised by terrorism. In each program, BioAttack and City Under Siege, moderators lead panelists through hypothetical scenarios of terrorist attacks. This two-part series explores some very hard choices facing leaders trying to prevent, prepare for, or respond to a terrorist attack: To what degree should our daily lives be altered in response to particular threats? When should information be shared with the public and when should it not? How far should the government go to get information about an imminent threat from an American citizen? How should critical resources such as personnel or medicine be distributed after an attack?

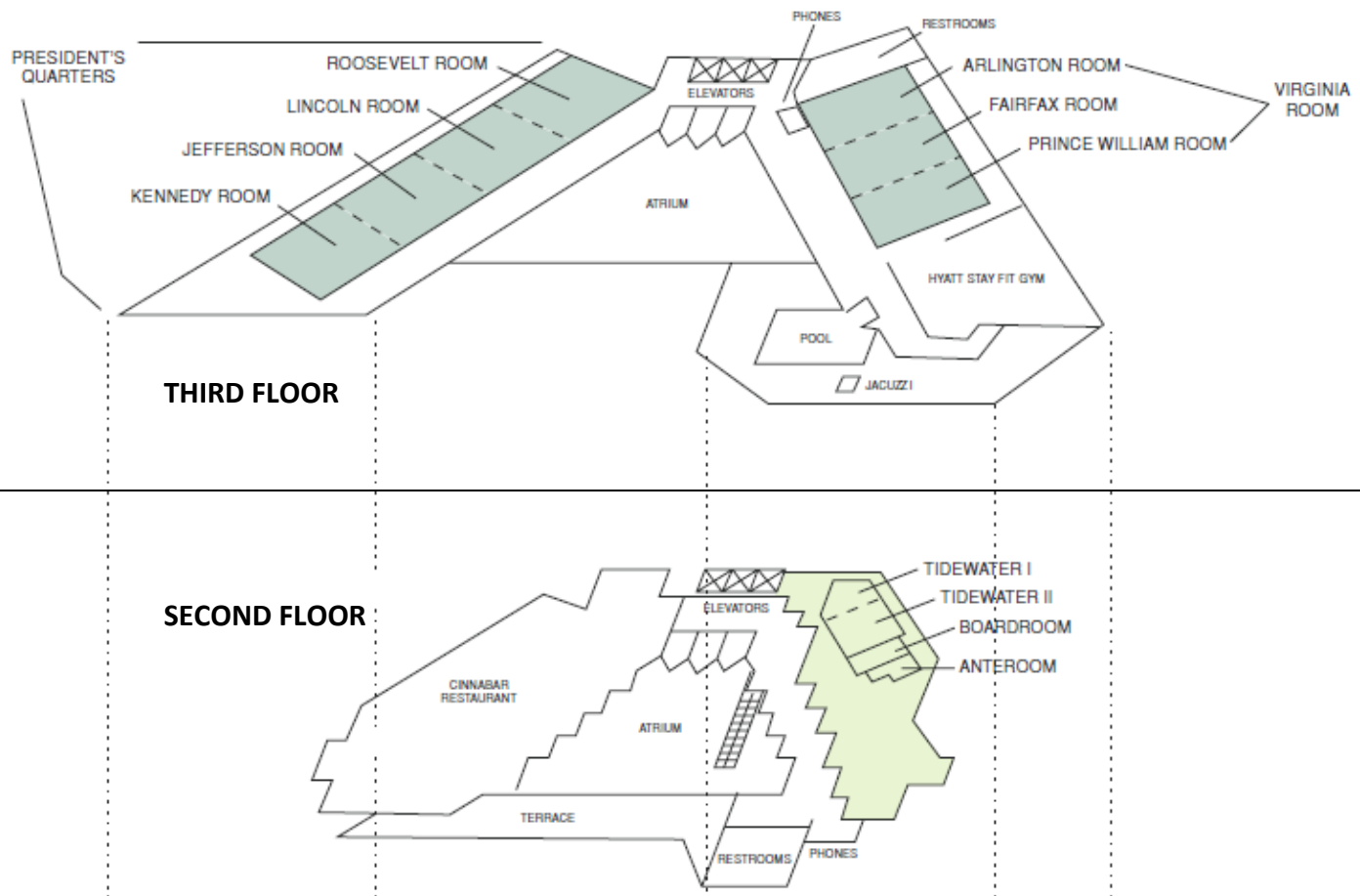

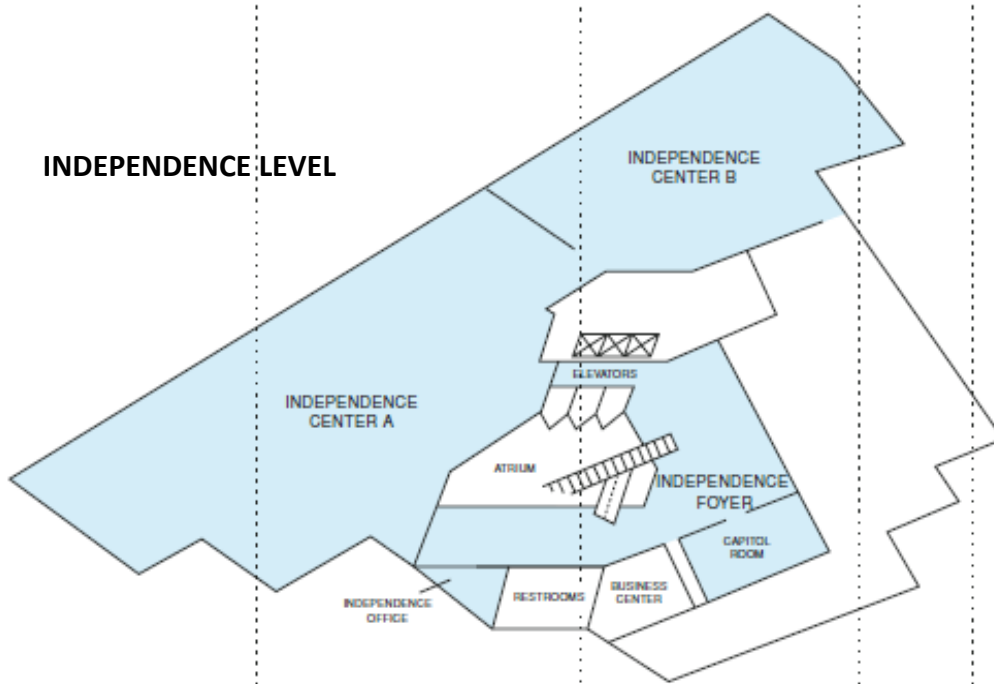
FLOOR PLAN



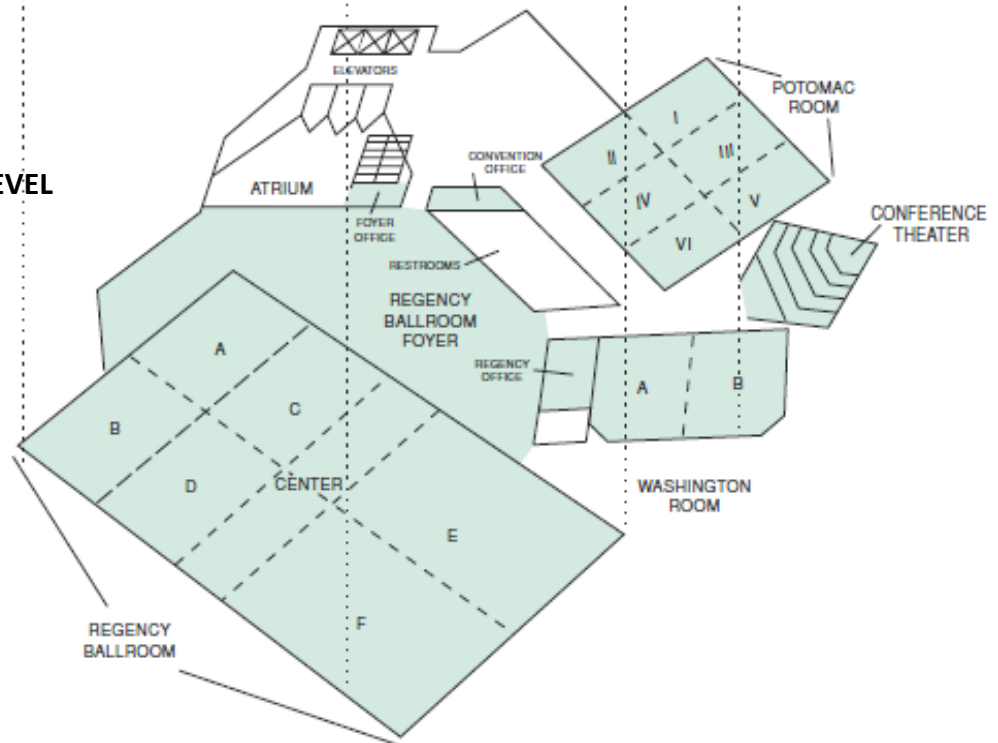

Citizen Preparedness Research

FEMA has sponsored several research projects to better understand the public's emergency preparedness and response activities. FEMA's Citizen Corps Surveys offer a comprehensive source of data on the public's thoughts, perceptions, and behaviors related to preparedness and community safety for multiple hazard types. Survey questions addressed several critical areas in the field of disaster preparedness research including elements of personal preparedness such as stocked supplies, plans, knowledge of community protocols, and training; elicited insights on barriers and motivators to preparedness; and tested social-behavior modeling on disaster preparedness, the Citizen Corps PDP Model. FEMA's Citizen Preparedness Reviews (CPR) are published periodically to summarize research findings in the field of disaster preparedness and to support local efforts to achieve greater community resilience.
