## **Instructor Levels**

**Lead Instructor** – An experienced professional who has successfully completed **E/L 449 OR a recognized equivalent** and has first-hand emergency response experience as a member of the **Incident Command System (ICS) command or general staff**. Lead Instructors must have completed the most recent version of the course they intend to teach, ensuring up-to-date knowledge and instruction and must have accumulated 40 teaching hours with the state of Nevada as an assistant instructor.

**Assistant Instructor** – A qualified trainer who has completed **E/L/K/G 141** or a **recognized equivalent Train the Trainer** program. They must also have completed the most recent version of the course they wish to teach to ensure familiarity with current standards and best practices. Assistant Instructors will co-teach with Lead Instructors.

## **Instructor Types**

**Partner Instructor** - An instructor who is employed by a partnering public safety or critical infrastructure agency and will be paid for instruction through that agency. Partner Instructors must have taken the most recent version of the course they plan to teach to ensure their expertise aligns with current instructional material and methodologies.

**Adjunct Instructor** – A **Subject Matter Expert (SME)** in the specific field they wish to instruct. Adjunct Instructors will be paid by the State of Nevada. Adjunct Instructors must have taken the most recent version of the course they plan to teach to ensure their expertise aligns with current instructional material and methodologies.
