On April 26, 2023, we presented the recommendations of the Urban Area Working Group and the Nevada Resilience Advisory Committee to the Committee on Finance. These projects are listed below by each group. The Committee on Finance entertained a dollar amount change between Clark County and Las Vegas for election security. These changes are:
