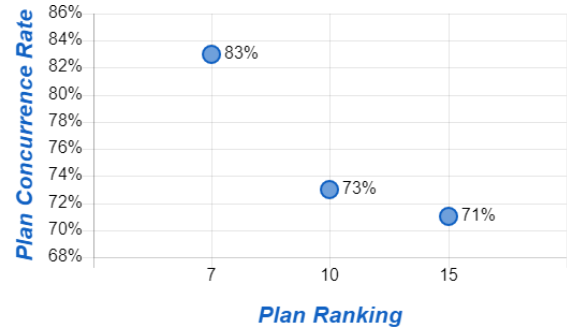
Concurrence and Ranking of Charter Reviewed Plans
