# Introduction of Position

- **Role = Department of Homeland Security (DHS) – Cybersecurity and Infrastructure Security Agency (CISA)**
  - **Cyber Security Coordinator (CSC) *and acting* Cyber Security Advisor (CSA) from CISA to the State of Nevada began role 2 August 2021 – New Program and Position**
- **Purpose = Partnering with State of Nevada Government Executive Branch and Critical Infrastructure for all matters Cyber Security**
  - **Inform**
  - **Assess**
- **Vision of the CISA and the CSA/CSC Program within Nevada for 2023 =**
  - **Assist in development of Cyber Security programs to include ESF-17 Cyber Security**

    - **Incident Response for Cyber**

- **Focus will be on Nevada's Government Executive Branch and Critical Infrastructure**
  - **Assessments (CIS, CRR, EDM, etc.)**
  - **Incident Response Plan Development**
  - **Assist with NRS 603a adherence**

      - **CIS or NIST RMF**
  - **Table Top Exercises (TTX)**
