1. **CALL TO ORDER AND ROLL CALL** – Joshua Fisher, Chair.
2. **PUBLIC COMMENT**– (Discussion Only) – No action may be taken upon a matter raised under this item of the agenda until the matter itself has been specifically included on an agenda as an item upon which action may be taken. Public comments may be limited to 3 minutes per person at the discretion of the Chair. Comments will not be restricted based on viewpoint.

3. **APPROVAL OF MINUTES** – (Discussion/For Possible Action) – Joshua Fisher, Chair. The SAR Board will discuss and review the minutes of the June 21, 2022, SAR Board meeting. The SAR Board will determine whether to approve the meeting minutes.
4. **SAR BOARD MEMBERSHIP** – (Discussion Only) – Joshua Fisher, Chair. Mr. Fisher will discuss the retirement of Steve Morris Jr. from the Board and the appointment of Matthew Marlow with Las Vegas Metro Search and Rescue. Richard Fenlason, Board Member. Mr. Fenlason will announce his retirement from state service and from the SAR Board.
5. **INTEROPERABILITY CHANNELS** – (Discussion/For Possible Action) – Joshua Fisher, Chair. The SAR Board will review the use of the National Interoperability Field Operations Guide (NIFOG) and the Nevada Tactical Interoperability Field Operation Guide (NEVIFOG) radio frequencies to address the utilization of radios for search and rescue (SAR) purposes. The Board may vote to approve the use of the NIFOG and NEVIFOG.
6. **TYPING SAR RESOURCES IN NEVADA** – (Discussion Only) – Joshua Fisher, Chair. Mr. Fisher will discuss the need to update the SAR Resources typing list. This will allow other SAR units in Nevada to see what could be requested to assist in a SAR in Nevada.

7. **SAR TRAINING OPPORTUNITIES** – (Discussion Only) – Rodney Wright, State SAR Coordinator. Mr. Wright will discuss some upcoming SAR training available to the state, and opportunities to bring in other possible trainings for SAR groups.
8. **AIR FORCE RESCUE COORDINATION CENTER (AFRCC)** – (Discussion Only) – Rodney Wright, State SAR Coordinator. Mr. Wright will discuss AFRCC, the process to request those resources from the state, and some of the information they require for requesting resources.
