INCIDENT NAME: Spring Thaw 2023

LOCATION: Nevada (Region 2)

TIME OF INCIDENT: 12:00 AM on 8MAR23

INCIDENT DESCRIPTION: The Nevada Operations Center (NVOC) is partially activated per the Division of Emergency Management (DEM) Spring Thaw Plan. The purpose of this activation is to increase our efforts for monitoring, preparedness, and supporting any jurisdictions in responding to flooding impacts.

CONDITIONS

CURRENT SITUATION (as of 12:00 PM on 13JUL23): Per the National Weather Service Reno, the first significant heat wave of the Summer reaches the region this weekend and into Monday with temperatures well into the 100s and may break record highs. There is an excessive heat warning in effect for Western Nevada and residents should stay hydrated and keep cool. The heat wave will be more prolonged in the Southern Nevada region with a possible record high of 117 degrees on Sunday. Elevated temperatures will ramp up snowmelt; however, snowpack is at lower levels decreasing the concern for appreciable flooding. Slight chance of thunderstorms to return on Sunday in the North. Rivers and streams in the Eastern Sierra including the Walker River system continue to run at elevated levels but peak flows have decreased. Keep an eye out for potential renewed flooding on Mono County small streams, especially Mono Basin and South. All flood gauges continue to be below the flood stage.
















SIGNIFICANT IMPACTS

- 1. **Mason Road is SR 827:** the Mason Bridge and roadway are state property and remain closed with HESCO Barriers across them to redirect water from the Walker River away from town. There is damage to the roadway that NDOT will repair after the water subsides. This will be a financial impact to the state.
 - Working on demobilizing HESCO Barriers at Mason Road as of 7/13/2023
- 2. **Miller Lane** is still closed with water over the roadway and is expected to a be total loss due to water damage by the Mason Valley Wildlife Management Area (MVWMA). WRID reports there is still a little bit of water running over the top of the roadway, but it is down significantly.
- 3. **Lux Lane** Water is receding on Lux Ln. south. They hope to get materials and equipment out there to regain access to homes and get fish out to lakes. **We received an estimate to fix a small area of state road to MVWMA, \$758,000 and is attached as PDF 1517 001.
- 4. **MVWMA:** NDOW still has 3 families that are displaced. Any emergency protective measures will be the responsibility of the state.
- 5. **NV Energy Churchill Station** is confident that the usage of a high clearance vehicle from the NETC will allow them to access the pump house if they need to get out there.
 - No new reports as of 7/13/2023
- 6. **Rail Road:** There is increased Subbing in this area and there is concern of impacts to the railroad tracks out of Hawthorne Army Depot.
 - No new reports as of 7/13/2023
- 7. **Weber Reservoir:** BIA reports water level is below the emergency spillway and the overall capacity is down to 53% capacity.
