TIME OF INCIDENT: 12:00 AM on 8MAR23

INCIDENT DESCRIPTION: The Nevada Operations Center (NVOC) is partially activated per the Division of Emergency Management (DEM) Spring Thaw Plan. The purpose of this activation is to increase our efforts for monitoring, preparedness, and supporting any jurisdictions in responding to flooding impacts.

CONDITIONS

CURRENT SITUATION (as of 12:00 PM on 22JUN23): Per the National Weather Service Reno, temperatures are warming this week however remain near to below normal season averages. An incoming weak low pressure system will increase chances for showers and isolated thunderstorms late Friday into Saturday. While recent cool weather has tempered flows over the last few days, expect high flows from snowmelt to continue across Eastern Sierra and flooding on the Walker River until further notice. The Walker River near Wabuska continues in moderate flood stage at 12.1 feet and is receding. The Walker River below Weber Reservoir near Schurz is at moderate flood stage at 18.63 feet and receding. All other gauges are below moderate flood stage.

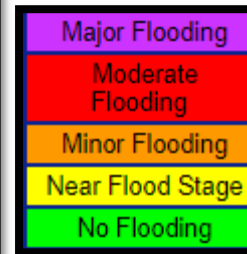
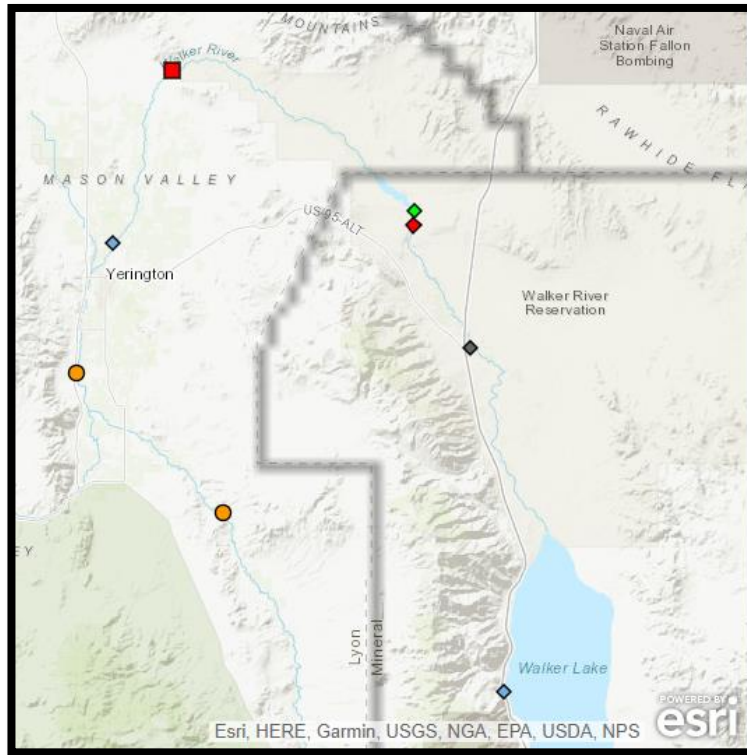
